#### NOTES

**1. STORMONT TENNIS & SQUASH CLUB** (the Club) is an operating name for Stormont Tennis & Squash Club Limited, a company limited by guarantee, no 15538079, into which the continuing activities, assets and liabilities of Stormont Lawn Tennis and Squash Rackets Club (the Old Club) will be transferred, effective as of 1 October 2024. Membership of the Company will entitle each member to the rights and obligations set out in the Company's Articles of Association (available on [www.stormonttsrc.com](http://www.stormonttsrc.com)). From that date, the Old Club will still continue to run off certain residual activities which cannot practicably be completely transferred to the Company. Further background to the transfer is on the Stormont website and in recent newsletters.

By signing the membership application form for 2024/2025 and agreeing to become a member of the Club, you will become a member of both the Old Club and the Company for this subscription year. As a member of the Company, you undertake to contribute £1 to the Company's assets in the event of it becoming insolvent and being wound up while you are a member or within one year of ceasing to be a member.

**2.** If renewing or joining as a **FAMILY MEMBER**, please also state which membership category you fall into e.g. **FAM 1/J1, FAM 1/J2, FAM 1/J3, FAM 2/J1** etc

**3. SQUASH PLAYERS – ENGLAND SQUASH MEMBERSHIP** is a requirement for team and other squash players competing in ES accredited tournaments. Stormont is an ES affiliated club. However, with effect from Autumn 2024, individual ES membership has become the responsibility of the individual player and ES will contact you directly inviting you to sign up.

**4. LTA BRITISH TENNIS MEMBERSHIP** Although British Tennis membership registered to Stormont is not a condition of membership of the Club, it is a condition of entry to the Wimbledon ticket ballot (next one in 2025) and of participation in Club tennis teams. British Tennis membership is free and confers a number of other benefits. For further details, go to the British Tennis website [www.lta.org.uk/membership](http://www.lta.org.uk/membership). If you are already a British Tennis member registered to Stormont but have forgotten your British Tennis membership number, contact British Tennis or email the Membership Secretary ([membership@stormonttsrc.com](mailto:membership@stormonttsrc.com)) for assistance. You may be registered to more than one tennis club.

**5. 10% DISCOUNT FOR MEMBERS RENEWING/JOINING EARLY.**

If payment is made no later than 1st October 2024, a discount of 10% applies to subscriptions (but not joining fees). Membership will be deemed to have lapsed if payment is not received from a renewing member by 15 November 2024, a further joining fee will become payable and our membership list may be closed to further new members in order to maintain tennis court availability for existing members.

**6. PRO RATA RATES** Pro rata rates apply to subscriptions for new members joining part way through the membership year calculated on a monthly basis.
